NYSE Liffe – access to eFills

Summary

This Notice provides Members with details regarding continued access to the eFills application following NYSE Liffe go-live.

1. Introduction and Background

- 1.1 NYSE Liffe Notice No. 1/2008, issued August 21, 2008, provided details of the migration of the CBOT's precious metals contracts to NYSE Euronext's new US futures exchange, NYSE Liffe. NYSE Liffe has reached agreement with the CME Group that the existing eFills application, operated under license from FFASTFILL UK Ltd, will remain available to NYSE Liffe members following the NYSE Liffe market go-live on September 7, 2008.
- 1.2 NYSE Liffe intends to enter into its own managed services agreement directly with FFASTFILL to provide the eFills service, which allows Members via a web based interface to view their executed trades independent of the NYSE Liffe trading platform infrastructure. Further information in relation to the timing of implementation of this agreement will be provided in the near future.

2. Access to eFills

- 2.1 With effect from September 7, 2008 access to the eFills service will continue to be available using the existing URL, <https://efills.cbot.com> with Members being able to log on via their existing usernames and passwords. The eFills reference guide is available on the NYSE Liffe website www.nyx.com/nyseliffe.

3. Operational Support

- 3.1 Business operational support for eFills will be provided by NYSE Liffe Market Operations Administration with effect from September 7, 2008. - 3.2 Any new requests for access to the eFills service should be made by completing the eFills Application Form (Attachment 1) and sending it to Market Operations Administration either by email or fax (+44) 20 7929 3554. All requests for access will require the prior signed approval of the relevant Clearing Member.
