General Information

Introduction

Market Maker Report (also known as MMR) output contains three report types: Daily, MTD and Active Symbol List which provides details information of all Market Maker statistics for by market maker type. The daily and month to date reports include volumes, rankings and percentage executed..

Equity Market Makers may opt for one or more of the following three report types:

1. **MM Daily Report** - daily statistical report of trades for the previous trading day. Market Makers can subscribe by Firm (CRD) but the statistical calculation is done on MPID+MMID level
2. **MM MTD Report** - daily report providing month to date totals for the trading month. Market Makers can subscribe by Firm (CRD) but the statistical calculation is done on MPID+MMID level
3. **Active Symbol List** - Daily report providing active symbol list designated for trading as a Market Maker for current business day. Report available for Firm CRD only.

Market Maker Report output is available for all market maker types on NYSE, NYSE Arca, NYSE National and NYSE American utilizing the same file format across all Equities Markets.

4. Output files will be made available for secure pick-up via Managed File Transfer (MFT).
 5. Output Files will be made available after ~ 11 p.m. daily.
- All files will be comma delimited and will not be sorted.
- Header records will not be provided.

For new reports, versioning will be supported. As new enhancements are made to these outputs, customers may expect to receive both current and new versions in their MFT folder. All new versions will be tagged with a version number which will then allow the customer to migrate to the new file format when ready. Advance notification of dates will be provided with a minimum of 30 day notice dependent upon size and scope of changes.

- a. After the migration timeframe has expired, customers will see only the latest version in their folders.
