

NYSE PILLAR CUSTOMER MANAGEMENT TOOL SETUP

To gain access to the NYSE Pillar customer management tool:

1. Complete the [Global ID Request and Two-Factor Authentication Registration](#) process Single Sign-On (SSO)
2. Submit the [User Request and Authorization Form](#) to crs@nyse.com. List your newly created Global ID on the form.
3. NYSE creates your account and notifies you of completion
4. Login to <https://cdm.nyse.com>

Detailed instructions for the above steps are outlined below.

STEP 1

Requesting a Global ID:

- Go to [Single Sign on Request page](#) to request a Global ID. Complete all fields and press the “Send Confirmation Email” button.

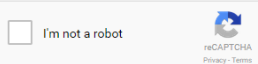
