

Q2 2016 ETP MARKET PERFORMANCE

- Total ETP assets under management (AUM) grew by nearly \$85 billion from the end of Q1 2016, representing 4% growth
- 81 new ETPs were listed in the U.S.
- U.S. ETP consolidated daily trading volumes increased to 1.54 billion from 1.15 billion in Q2 2015, representing a 33% increase

Q2 2016 NYSE ARCA HIGHLIGHTS

- 34 new ETPs listed on NYSE Arca, bringing the current listings total to 1,565 ETPs
- 11 issuers listed their products with NYSE Arca
- NYSE Arca ended Q2 with 81% of all listings, and a total of 92% AUM across all issues
- NYSE Arca's market share of ETP trading increased from 21.8% in Q1 to 23.4% in Q2

NYSE GROUP MARKET STRUCTURE UPDATES

After gathering feedback from a wide range of market participants regarding potential market structure changes, NYSE Group earlier this year published an analysis identifying a number of actions to improve the stability of the equity and ETP markets. A number of these recommendations have been completed, and others are in progress via regulatory filings and industry working groups.

Highlights of completed actions include:

- Widening of NYSE Arca's core opening collars to 3, 5, and 10%
- Enhancement of the NYSE Arca Lead Market Makers (LMM) program for market makers in less liquid ETPs
- Widening of the parameters for re-opening under NYSE Arca's auction collar logic
- Dissemination of NYSE imbalance feed data until the opening of the security
- Elimination of Stop orders and Good Until Cancelled orders on NYSE
- Increased education and outreach efforts to an even larger population of market participants

Highlights of in progress enhancements include:

- Approval of rule changes for additional operating efficiencies in NYSE opening procedures on volatile days
- Active NYSE membership on the Limit Up Limit Down (LULD) Advisory Committee, Operating Committee, and Working Groups to harmonize procedures for re-opening securities following a LULD halt
- Regulatory filing for generic listing standards for active non-transparent ETFs

"The majority of new products continue to launch on NYSE Arca, the leading exchange for ETP listing and trading. The evolution of these markets, rising demand for new products, and the development of deep and efficient markets remain the key areas of focus," said Doug Yones, NYSE Head of ETPs.
