

- In April, **5 new ETFs**¹ listed on NYSE Arca
 - At the end of April, **1,514 ETFs** were listed on NYSE Arca
- US ETP notional volume represented **27.49%** of all CTA issues in April 2017
- US ETP daily average turnover was approximately **\$72.01** billion in April 2017
- NYSE Arca was at the NBBO **92.66%** of the time, leading all US exchanges
- NYSE Arca had 23.10 % of all US ETP trading volume, leading all US exchanges




